



A) Please complete the Travel Request Form below and mail it to the address shown at the bottom of the form and please list your vacations in preferred order. Include a \$50 (refundable deposit) per person in the form of a postal money order, money order or cashier's check only. The envelope must be postmarked no more than 21 days after your sponsor's issue date listed below. Upon validation, Millennium Travel will then mail you a Reservation Request Form.

B) You must choose three dates on your Reservation Request Form, allowing for at least 45 days between choices. Mail the request back to us at least 60 days before the earliest chosen date.
